Dear Whitney,

The evaluation committee has completed the review and evaluation of proposals for the Razorapp mobile application platform under RFP 648907. Proposals were received from the following vendors:

- 1. Few
- 2. Modo Labs
- 3. High Point

After receiving all the proposals the evaluation committee met on 09-06-2017 with all committee members present. We discussed the various proposals to determine the best fit for the university. Following the discussion, the committee determined that we had all the information from Few and High Point Technology Solutions, however; we needed clarification from MODO Labs about their software implementation process and guidelines. With your help and supervision we were able to secure a presentation time with MODO Labs for 09-20-2017. For the 09/20 clarification presentation by MODO Labs, all committee members with exception of one member were present. At the conclusion of the presentation it became clear that we needed another presentation with some actual data sources from university. Ultimately we scheduled the second clarification meeting for 09/27/2017 and informed your office prior to the presentation. On 09-27-2017 I requested that you help us to request the best and final offer (BAFO) to all the vendors. Your email request to the vendors was sent on 09-26-2017. You have copied me on two vendor email responses to the BAFO. Based on your emails, two vendors are indicating that the price they gave us for the original proposal still stands. I know you are waiting for the written responses with 10-03-2017 deadline. For the Sept 27th all committee members were present. Following the presentation, committee members agreed that we had adequate information to prepare the technical score. I provided the committee members the scoring guidelines and deadline.

Unfortunately On October 2, we were notified by the University Information Technology department that they are unable to fund the project. So Due to lack of funding at this point we have decided to proceed with No Award for the RFP 648907

The committee wishes to thank each respondent for their interest in doing business with University of Arkansas, and for their efforts, and their efforts in responding to the RFP. Thank you for your assistance with this RFP process.
